**SUBJECT:** Preliminary Discussion for the Preparation of a False Alarm Ordinance

**REPORT IN BRIEF**

This Administrative Report provides the information and data requested by the City Council for the preparation of a False Alarm Ordinance.

**RECOMMENDATION**

Provide direction to staff on a variety of issues relating to a False Alarm Ordinance.

Chief Deputy City Attorney Kelly FINCHER gave a slide presentation giving a timeline of the False Alarm Ordinance and gave a road map of the discussion for the item.

Marvin DILLSAVER, Dispatch Supervisor gave a data-driven presentation that showed the number of false alarm calls for the last five years, including major offenders and most common reasons for false alarms.

Attorney FINCHER discussed the different costs for implementing the program in-house versus hiring an outside consultant. She suggested a possible separate fee schedule for the school system. She gave a brief overview of a pilot program developed by staff. She stated staff would report back after six months on how the program was working.

Steve KEIFER, Security Alarm Coalition - spoke about different cities he has worked with to improve calls for service in regards to false alarms. He explained different ordinances, permits and fees.

Council discussed permits, a different fee schedule for schools, and options regarding running the program in-house or hiring a third party vendor.

Council Member BELLUOMINI questioned first-year costs and future year costs.

Attorney FINCHER stated that first-year costs were expected to be higher than subsequent years but that staff could only estimate costs at this time.

Mayor THURSTON was concerned about making sure that all alarm owners had permits.

Mr. KEIFER stated that most reputable alarm companies made sure their customers complied with all ordinances and required permits.

Council Member DOSSETTI voiced his support for an ordinance.

Council Member MURPHY voiced his support and questioned the function of the permit.

Attorney FINCHER stated that the permit could be a revenue stream or just have all contact and monitoring company information.

Rick McMILLION, Merced - spoke about call lists for businesses before police are dispatched.

Juan MENDOZA, Merced City School District - spoke about the efforts being made to reduce the number of false alarms from schools.

John CURRY, Superintendent at Weaver School District - spoke on the efforts being made to reduce false alarms at the schools. He spoke in favor of an ordinance and a permit.

There was a consensus among Council to set up a pilot program for nine months with a free permit, have a single fee system similar to the City of Atwater with one free false alarm after taking a webinar or class.

Victor CALDERON, Merced - suggested requiring the training in advance of false alarms.
