AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MERCED, CALIFORNIA, AMENDING SECTIONS 10.28.230, "NO PARKING ZONES" AND 10.32.050, "FREIGHT AND PASSENGER LOADING ZONES – LOCATIONS," OF THE MERCED MUNICIPAL CODE AND ADDING SECTION 10.32.051, "FREIGHT AND PASSENGER LOADING ZONES – LOCATIONS – SEVEN A.M. TO FOUR P.M.," TO THE MERCED MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN AS FOLLOWS:

SECTION 1. AMENDMENT TO CODE. Section 10.28.230, "No Parking Zones," of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

SECTION 2. AMENDMENT TO CODE. Section 10.28.230, "No Parking Zones," of the Merced Municipal Code is hereby amended by adding the following portions of the following streets:

Beginning at the southern

curb return of Childs

Avenue, thence southerly to the northwest property line

of APN 061-400-083.

South side of

Loughborough Drive

Beginning at the northeast property line of APN 236-

310-007, thence westerly 20

Beginning 185 feet north of the southeast property line of APN 061-340-017, thence northerly 20 feet.

South side of West 22nd

Beginning at the point that is 117 feet west of the western curb return of M Street, thence westerly 7 feet.

Beginning at the point that is 149 feet west of the western curb return of M Street, thence westerly 15 feet."

SECTION 3. AMENDMENT TO CODE. Section 10.32.050, "Freight And Passenger Loading Zones – Locations," of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

24 feet west of the centerline of Willow

Avenue, thence easterly 66

feet."

SECTION 4. AMENDMENT TO CODE. Section 10.32.051, "Freight and Passenger Loading Zones – Locations – Seven a.m. to Four p.m.," is hereby added to the Merced Municipal Code to read as follows:

"10.32.051 - Freight and Passenger Loading Zones—Locations – Seven a.m. to Four p.m.

When authorized signs or curb markings are in place giving notice thereof, the locations described in the following paragraphs are designated as freight and passenger loading

zones during the time period of seven a.m. to four p.m., excepting Saturdays, Sundays, and holidays.

20th Street

Portion:
Beginning at a point that is 24 feet west of the centerline of Willow Avenue, thence easterly 66 feet."

SECTION 5. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 6. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 7. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.
