#### **REPORT IN BRIEF**

Director of Public Works Ken ELWIN explained that the dollar amount in question would be the same use and that it shouldn't be doubled. He also stated that the fee that would have been for the Police Station would transfer to the new owner of the property. He stated that fees would be different in different districts based on coverage area.
