03/28/2013 -3/28/13 SEQ#1: The purpose of this request is to authorize \$212,472 of H120 federal fund for the PE phase using Lump Sum.

04/17/2014 Request is for additional \$53,118 federal STP (H120) funds to complete the PE phase (post-programming), as part of the local agency's bridge preventive maintenance plan (BPMIP).

04/28/2015 Request is for additional \$35,412 federal STP funds as post-programming to complete all required environmental studies, preliminary design, and subsequently final design as part of the local agency's bridge preventive maintenance plan (BPMIP). Final design shall not begin prior to NEPA clearance. Agreement end date = September 30, 2023.

05/04/2016 This E76 is Request for Authorization (RFA) to proceed with Construction. This request is for \$1,707,744 federal funds for Construction Contract and Construction Engineering (CE). Sequence #4 is a request for construction and construction engineering funding to implement bridge preventative maintenance measures on the G Street and M Street bridges over Bear Creek in the City of Merced under the Bridge Preventive Maintenance Program (BPMIP) in SAFETEA-LU's Highway Bridge Program. (HBP) using funds programmed for FY 16-17 in Amendment #10 approved on 11/17/15 to MCAG's 2015 FTIP and EPSPd to FY 15-16 on 4/20/16. Funding for preliminary engineering was previously obligated. Federal funding under this request is limited to \$1,707,744 for construction with a maximum

reimbursement ratio of 88.53%. Reimburse with 2001 HBP funds at 88.53% on a lump sum reimbursement basis up to the federal amounts shown for construction and construction engineering. Br. Nos. 39C-0028 and 39C-0041.
