#### **B. STUDY SESSION**

B 1 SUBJECT: Joint Study Session with City Council/Planning Commission to Discuss Medical Marijuana

#### REPORT IN BRIEF

A joint Study Session with the Planning Commission and City Council to discuss Medical Marijuana.

SCI Consulting Group representative Neil HALL gave a slide show presentation on the process of implementing medical marijuana dispensaries.

Council Member PEDROZO asked about the guidelines for the merit-based system.

Mr. HALL explained that there would be collaboration with staff to develop criteria for the merit-based system.

Council Member MARTINEZ asked if a medical marijuana dispensary could also sell recreational marijuana.

Council Member BELLUOMINI asked if notifications would be sent to property owners through the Special Land Use Permit process. He also discussed recreational use and deliveries.

Council Member MARTINEZ asked if a dispensary could also deliver products.

Mayor MURPHY explained that the ordinance allows a dispensary to deliver product as well.

Planning Manager Kim ESPINOSA explained in more detail the process of the Special Land Use Permit and noted that special noticing stipulations could be put in place.

Susan BOUSCAREN, Merced - spoke on the labor peace agreement requirement.

Luke BRUNNER, Arcata - spoke on his company, Canna Group, and encouraged expanding the zoning of the ordinance.

Will SKAARUP, Eureka - spoke on cannabis and wanting to bring his business to Merced.

Zach DRIVON, Stockton - spoke on his experience with his client on the process of obtaining a cultivation business. He also offered his services as a resource.

Dwight LARKS, Merced - spoke on allowing dispensaries downtown. He also spoke on utilizing the empty warehouses and creating job opportunities.

Council Member PEDROZO discussed the Special Land Use Permit and expanding the cultivation discussion.

Planning Commissioner SMOOT encouraged the Council and fellow Commissioners to visit other cities' dispensaries.

Planning Commission Chair DYLINA asked about other types of businesses that the City places limits on and if they might request the Special Land Use Permits. He also spoke on indoor cultivation.

Council Member BELLUOMINI requested further discussion on cultivation.

Planning Commission Vice Chair BAKER asked for justification of the Special Land Use Permit. He further discussed on-site consumption.

Ms. ESPINOSA explained the difference between Conditional Use Permit

and Special Land Use Permit.

Council Members, Ms. ESPINOSA, and Planning Commissioners further discussed the Special Land Use Permit.
