RESOLUTION NO. 2017-____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MERCED, CALIFORNIA, APPROVING THE 2017 HUD ANNUAL ACTION PLAN, CERTIFYING COMPLIANCE WITH THE REQUIREMENTS OF THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM AND HOME INVESTMENT PARTNERSHIP (HOME) PROGRAM, AND AUTHORIZING STAFF TO SUBMIT ALL APPROVED DOCUMENTS TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) has determined that the City of Merced is estimated to receive \$1,310,417 under the Community Development Block Grant (CDBG) and Home Investment Partner Program (HOME) program year 2017-2018 of the Housing and Community Development Act of 1974, as amended; and

WHEREAS, the City of Merced held three community meetings on November 20, 2016, December 15, 2016 and January 26, 2017, with public meetings on April 3, 2017 and July 17, 2017, with public hearings on April 17, 2017 and August 7, 2017; to consider public comments and proposals regarding the 2017HUD Annual Action Plan; and

WHEREAS, during said meetings information was provided about HUD's National Goals and Objectives, the City of Merced's 5-Year Consolidated Plan, and discussion held about eligible uses of CDBG and HOME funds in the City of Merced; and,

WHEREAS, the City of Merced has provided citizens with an opportunity to review and comment on concerns involving the amount of funds available for proposed housing and community development, the range of activities and program requirements, and provided citizens with adequate opportunity to participate in development of the 2017 HUD Annual Action Plan, including any submissions, revisions, changes or amendments thereto for a 30-day period commencing on March 16, 2017 and ending on April 17, 2017; and thereafter with an opportunity to review the revised 2017 HUD Annual Action Plan for a 30 day period commencing on July 6, 2017 and ending on August 7, 2017.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MERCED DOES HEREBY RESOLVE, DETERMINE, FIND, AND ORDER AS FOLLOWS:

SECTION 1. The City Council of the City of Merced hereby approves the 2017 HUD Annual Action Plan. The City Manager is hereby authorized to execute all documents related thereto, and staff is authorized to submit all documents to the United States Department of Housing and Urban Development.
