Describe the geographic area(s) to be covered by the planning activity:

This planning study involves investigating the feasibility of diverting flood discharges from Fahrens Creek upstream of the City of Merced into the Main Canal during the winter wet season when flows in the canal and storage within Lake Yosemite are minimal. The diverted flows will be temporarily stored within Lake Yosemite. Once floods have receded, the stored water will be released slowly into LeGrand Canal and diverted into Black Rascal Creek through a new side gate structure on the south embankment. Fahrens Creek runs through the City of Merced and experiences severe flooding due to overflows. While structural alternatives occur upstream of the City of Merced on the Main Canal, Lake Yosemite and LeGrand Canal, the potential project benefits include over 400 residential structures within the City of Merced and Merced County.

The purpose of this multiple-benefits planning study will be to investigate a combination of project alternatives along a section of Fahrens Creek from Buena Vista Drive to a point approximately 2 miles upstream of Snelling Highway that will result in reduced flood elevations and frequencies for the over 400 residential structures located within the Special Flood Hazard Area. This has been illustrated in the attached annotated map. The City of Merced in coordination with Merced Irrigation District and Merced County will implement this planning activity. Additional stakeholders including the public will be given an opportunity to review and provide input for the plan. Regulatory agencies will be engaged to determine the required permits needed to implement the selected project alternative. An array of project alternative designs will be investigated to identify the most effective and potentially feasible approaches to improve flood conveyance and reduce flood frequency and elevations within this study area. This will include a hydrologic, hydraulic and economics assessment of both flood risk and concept level project implementation cost. A key goal will be to improve conveyance at the downstream end of the Fahrens Creek side channel/existing detention basin to divert increased flood discharges from the undersized natural channel of Fahrens Creek into the detention basin. These project alternatives will aim to reduce flood risk for the approximately 200 residential structures within the Special Flood Hazard Area adjacent to and upstream of West Yosemite Avenue. A project feasibility study performed through Advanced Assistance is expected to demonstrate significant flood risk reductions that will determine the potential level of protection for proposed versus existing conditions. Following successful

planning activities, the selected project alternative will be presented to the City of Merced County and Merced Irrigation District Board for formal approval. Once adopted the plan will be revisited and revised every 5 years until which time the proposed project alternative is constructed.

What are the primary sources of information and data and how it will be incorporated into existing planning mechanisms?

Primary sources of data used for this study will include existing FEMA hydraulic models recently updated and modified by the City of Merced. Additionally existing LiDAR data will be used to refine the model. Existing tax assessor information and GIS data will be used to support the economic assessment of flood risk and project benefits.

What staff and resources will be used to implement this planning activity?

The city of Merced and Merced Irrigation District will collaboratively manage the study to be performed qualified contractors.
