Description of Services

City Engineer Services

PCE will assign a dedicated Licensed Civil Engineer to perform the City Engineer services as requested. The CIty Engineer will attend meetings, review, sign and stamp plans and documents as requested.

Design Services

PCE will provide design services to the City as follows:

Utility/Infrastructure master Planning Services

PCE will perform master planning and updating of current master plan documents for the City's sewer, water, flood control, storm drainage system, and solid waste systems, as requested. PCE will prepare Groundwater Management Plans, Urban Water Management Plans, and Storm Water Management Plans (MS-4) Permit, to name a few, as requested by the City.

Topographic Field Survey and Boundary

PCE will perform topographic field surveys, boundary surveys, process survey data, and provide the City with a completed topographic survey in AutoCAD Civil 3D. Boundary surveys will be reviewed and prepared by a Licensed Land Surveyor.

Design Services for Capital Improvement Projects

PCE will provide design services for Capital Improvement Projects. PCE will prepare construction plans, specifications, and engineers cost estimate. PCE will provide 30% conceptual/schematic design, 60% design, 90% design, and 100% construction drawings.

Traffic Engineering Services

PCE will prepare traffic signal striping and signage plans. If requested, PCE can perform traffic counts and prepare traffic impact analyses, including traffic signal warrant analysis, stop sign warrant analysis, spot speed studies and provide recommended speed limits, stopping sight analysis, roundabout analysis and design.

Pavement Management Services

If requested, PCE can provide pavement management services, including setting up a pavement management system/software, perform pavement condition inspections, perform pavement modeling, update pavement cost indices, and provide a recommended pavement rehabilitation plan.

Land Surveying and Mapping Services

Proposal and Bidding Services

PCE will provide the City assistance with preparation of proposals and bidding documents. PCE will attend and facilitate pre-proposal meetings and walkthroughs. If requested PCE can provide the City with a list qualified firms and/or contractors that can perform the services requested to complete the projects. PCE will assist the City staff in reviewing bids, and proposals, conduct and facilitate proposal interviews, assist the City in the cases of bid protests and provide recommendations.

Construction Administration

PCE will provide construction oversight and administration when requested. PCE will coordinate with other city staff, departments, and contractors necessary. PCE shall monitor construction progress and provide the city with report. PCE will review contractors' materials and specifications submittals and provide the City with recommendations. PCE will review contractors request for substitutions, request for information, and shop drawings. PCE will provide the City with a response and recommendation for the request. PCE will assist the City in reviewing Contractors request for payment, and provide recommendations for payment. PCE will assist the City and provide recommendations for claims made by the Contractor.

Construction Inspection Services

PCE will provide construction services for capital improvement projects and private development projects as requested. PCE will provide the City with daily inspection notes and photographs, and contractors estimated man hours based on visual inspections. PCE will attend and facilitate pre-construction meeting. Upon project completion PCE will facilitate and conduct the final walkthrough inspections and provide the City with a recommendation punch list of items to be repaired or addressed. PCE will assist the City in preparation and filing of the Notice of Completion.

Davis Bacon/Prevailing Wage Compliance Review

PCE will provide random onsite interviews with contractor employees to verify compliance with Davis Bacon/Prevailing Wage regulations. PCE will assist the City in reviewing Contractors payment request, reported hours, labor rates, and copies of payroll records to verify compliance and provide the recommendations to the City of payment.

Development Impact Fee Updates

PCE can assist the City in updating the City's development impact fee program. PCE will perform research, update infrastructure master plans, developable area maps, construction cost indices, analyze city staff man hours, and provide a recommendation to the City. If requested, PCE can review the City's development fee program, entitlement applications, and other fees and provide recommendations for adjustments, or new fees to capture lost revenues that are not being recovered. PCE will attend regular Development Review Committee Meetings, meetings with the developer, Planning Commission, and City Council meetings as requested.

Expert Witness Services to City Attorney

PCE will provide Expert Witness Services to City Attorney and Public Work Director as requested. PCE will attend briefings, depositions, hearings, and trials, as requested.

Landscape Architecture

PCE will provide landscape architecture services for preparation of plans and specifications for landscape planting plans, irrigation plans, parks and recreation, play equipment, parks facilities such benches, drinking fountains, covered patio, picnic tables, to name a few. PCE will provide 30% conceptual layout, 60%, 90% and 100% construction plans for parks, trails, recreation facilities, and public open space areas.
