(F) BICYCLE ADVISORY COMMISSION EVOLUTION

Mr. HREN presented the draft changes to the Ordinance that empowers the Commission, and explained that the proposal from the Active Transportation and Safe-Routes-to-School Plan is to expand the scope of the Commission to include pedestrian and disability-related issues. Mr. HREN also explained that the likely direction of all City Commissions and Committees is to have district-based representation. The Commission noted that assistance from City Council members to fill vacancies in their Districts would be helpful in the event that the Commission moves to district-based representation.

The Commission considered potential scheduling changes and discussed other potential changes. They provided recommendations to Mr. HREN about draft language.
