Damon RAMIREZ, Merced - suggested adding more water fountains and lights around the skate park in McNamara Park. He also spoke on a sports scholarship.

Mark LOPEZ, Merced - spoke on the violence in his community and a sports scholarship.

Noe GOVEA, Merced - spoke on his concerns on the Understanding Drugs and Alcohol Program for at-risk youths.

Jesse ORNELAS, Merced - spoke on the displaced youth documentary, a campaign to help at-risk youths, the memorandum of understanding between the Merced Police Department and the school district, and the community violence in South Merced.

Sol RIVAS, Building Healthy Communities, Merced - spoke on Measure Y funds and a stronger community and police relations.

Salvador SANDOVAL, Merced - asked about the proper procedure for placing a complaint with the police department.

Gloria SANDOVAL, Merced - spoke on the homeless issue, vacant homes, and fixing streets. She asked about a report from the fire department on vacant house fires.

Ronnie DEANDA, Merced - spoke on the State of the City event, the lack of development by Highway 59 and other parts of South Merced, and the lack of an urgent care and hospital in south Merced.
