AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MERCED, CALIFORNIA, **AMENDING SECTIONS 10.16.010, "SPEED** LIMITS;" 10.28.230, "NO PARKING ZONES;" 10.28.275, "DISABLED PERSONS – ON-STREET **PARKING;" 10.28.370, "TWO-WAY STOP INTERSECTIONS;" AND 10.32.057, "PASSENGER** LOADING ZONES - LOCATIONS - SEVEN A.M. TO FOUR P.M." OF THE MERCED MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN **AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Section 10.16.010, "Speed Limits," of the Merced Municipal Code is hereby amended by adding the following speed limit:

"Street:

22 T I

Portion:

Shirley Street

Twenty-five (25) miles per hour

from Yosemite Parkway to

Merced Avenue"

SECTION 2. AMENDMENT TO CODE. Section 10.28.230, "No Parking Zones," of the Merced Municipal Code is hereby amended by adding the following portions of the following streets:

Street.

Portion:

West side of Willowbrook

Drive

Beginning at a point 375 feet (225 feet east and 150 feet south) from the east line of State Route 59, on the west side of Willowbrook Drive, thence southerly 46 feet.

Beginning at the west line of 'M'

Both sides of alley between West Main Street and West

18th Street.

Street, thence westerly to the east line of 'N' Street.

West and East side of Kelly

Avenue

Beginning at a point 43 feet from the north line of State Route 140,

thence northerly 100 feet.

West side of 'V' Street Beginning at a point that is 26 feet

northeast of the north line of Wardrobe Avenue, thence northeasterly 125 feet.

East side of Kibby Road Beginning at a point that is 45 feet

north of the north line of East Childs Avenue, thence north 125

feet."

SECTION 3. AMENDMENT TO CODE. Section 10.28.275, "Disabled Persons – On-Street Parking," of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

"Street: Portion:

South side of 22nd Street Beginning at a point that is 185

feet west of the west line of Martin Luther King Jr. Way, thence westerly 25 feet."

SECTION 4. AMENDMENT TO CODE. Section 10.28.370, "Two-Way Stop Intersections," of the Merced Municipal Code is hereby amended by adding the following portion of the following street:

"Approaching Streets

At Any Entrance Thereof With:

Required to Stop:

West 21st Street

"P' Street."

SECTION 5. AMENDMENT TO CODE. Section 10.32.057, "Passenger Loading Zones – Locations – Seven a.m. to Four p.m.," of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

"Street:

Portion:

South side of East 18th Street

Beginning at a point that is 204 feet east of the east line of 'F' Street, thence easterly 20 feet."

SECTION 6. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 7. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 8. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.
