The Consolidated Plan:

- Designed to help the City to assess affordable housing and community development needs.
- Assists in making investment decisions and strategies.
- Planning process creates a community-wide dialogue to identify housing and community development priorities.
- Crucial process in correctly focusing available HUD funding.
- 5-year plan

The Annual Action Plan:

- Provides a summary of the projects, activities, and federal and non-federal resources that will be used for the next year.
- Puts Con Plan's priority needs and goals into action.
- 1-year plan

Analysis of Impediments to Fair Housing Choice (AI):

- Purpose: to examine how laws, regulations, policies, procedures, and practices have affected the location, availability, and accessibility of housing in a given area.
- Viewed as the current state of fair housing choice.
- Identifies specific barriers, or impediments, that need to be addressed in the community.
- At this time, not subject to a HUD 30-day public comment period.
