**AN ORDINANCE OF THE CITY COUNCIL OF
THE CITY OF MERCED, CALIFORNIA,
AMENDING SECTIONS 10.28.335 "THIRTY-
MINUTE PARKING ZONES - ALLDAY", 10.28.341
"THIRTY-MINUTE PARKING ZONES –EIGHT-
THIRTY A.M. TO ONE-THIRTY P.M.", 10.28.350,
"TEN-MINUTE PARKING ZONES", 10.32.057
"PASSENGER LOADING ZONES – SEVEN A.M.
TO FOUR P.M.", 10.32.058, "PASSENGER
LOADING ZONES – SEVEN A.M. TO EIGHT-
THIRTY A.M. AND ONE-THIRTY P.M. TO
THREE-THIRTY P.M.", 10.32.100, "BUS ZONES",
10.32.100, "SCHOOL BUS LOADING ZONES", OF
THE MERCED MUNICIPAL CODE**

**THE CITY COUNCIL OF THE CITY OF MERCED DOES ORDAIN
AS FOLLOWS:**

SECTION 1. AMENDMENT TO CODE. Section 10.28.335, "Thirty-minute parking Zones – All day", of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

Street:

"South side of West 11th Street

Portion:

Beginning at a point that is 82 feet
east of the east line of Canal
Street, thence easterly 90 feet."

SECTION 2. AMENDMENT TO CODE. Section 10.28.335, "Thirty-minute parking Zones – All day", of the Merced Municipal Code is hereby amended by adding the following portion of the following street:

Street:

"South side of West 11th Street

Portion:

Beginning at a point that is 122
feet east of the east line of Canal
Street, thence easterly 60 feet."

SECTION 3. AMENDMENT TO CODE. Section 10.28.341, “Thirty-minute parking Zones –eight-thirty a.m. to one-thirty p.m.”, of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

<i>Street:</i>	<i>Portion:</i>
“South side of West 22nd Street	Beginning at a point that is 206 feet west line of R Street, thence westerly 80 feet.”

SECTION 4. AMENDMENT TO CODE. Section 10.28.350, “Ten-minute parking Zones”, of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

<i>Street:</i>	<i>Portion:</i>
“East side of S Street	Beginning at a point that is 80 feet south of the south line of West 22nd Street, thence southerly 72 feet.”

SECTION 5. AMENDMENT TO CODE. Section 10.28.350, “Ten-minute parking Zones”, of the Merced Municipal Code is hereby amended by adding the following portion of the following street:

<i>Street:</i>	<i>Portion:</i>
“East side of S Street	Beginning at a point that is 25 feet south of the south line of West 22nd Street, thence southerly 125 feet.

East side of S Street	Beginning at a point that is 20 feet north of the north line of West 21st Street, thence northerly 100 feet.”

SECTION 6. AMENDMENT TO CODE. Section 10.32.057, “Passenger Loading Zones – Seven a.m. to four p.m.”, of the Merced Municipal Code is hereby amended by deleting the following portion of the following street:

Street:
"East side of S Street

Portion:
Beginning at the south line of
West 21st Street, thence southerly
to the north line of West 20th
Street."

SECTION 7. AMENDMENT TO CODE. Section 10.32.058,
"Passenger Loading Zones – Seven a.m. to eight-thirty a.m. and one-thirty p.m. to
three-thirty p.m.", of the Merced Municipal Code is hereby amended by deleting
the following portion of the following street:

<i>Street:</i> "South side of West 22nd Street	<i>Portion:</i> Beginning at a point that is 206 feet west line of R Street, thence westerly 80 feet."

SECTION 8. AMENDMENT TO CODE. Section 10.32.100, "Bus
Zones", of the Merced Municipal Code is hereby amended by deleting the
following portion of the following street:

<i>Street:</i> "East side of S Street	<i>Portion:</i> Beginning at a point that is sixty- seven (67) feet from the beginning of the southeast line of West 22nd Street, thence southerly two hundred twenty-six (226) feet.
On the easterly curb line of S Street	Beginning at a point which is fifty-seven (57) feet south of the south property line of West 22nd Street, thence south eighty-three (83) feet."

SECTION 9. AMENDMENT TO CODE. Section 10.32.100,
"School Bus Loading Zones", of the Merced Municipal Code is hereby amended
by adding the following portion of the following street:

Street:
"East side of S Street

Portion:
Beginning at a point that is 20 feet
north of the north line of West 21st
Street, thence northerly 100 feet."

SECTION 10. EFFECTIVE DATE. This Ordinance shall be in full force and effect thirty (30) days after its adoption.

SECTION 11. SEVERABILITY. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 12. PUBLICATION. The City Clerk is directed to cause a summary of this Ordinance to be published in the official newspaper at least once within fifteen (15) days after its adoption showing the vote thereon.
