City Manager Stephanie DIETZ briefly introduced the American Rescue Plan Act (ARPA) Strategic Investment Plan.

Erick SERRATTO, Merced County Department of Workforce Investment, Merced - gave a slideshow presentation updating Council on the Merced Youth Job Program.

Council and Mr. SERRATTO discussed the outreach to undocumented youth, grants the Merced Youth Job Program has received, allocation of funds, and the progress of youth in the program.

Mrs. DIETZ gave a slideshow presentation on the ARPA Strategic Investment Plan and gave Council an update on ARPA funded projects.

Council, Mrs. DIETZ, Director of Development Services Scott MCBRIDE, and Director of Information Technology Jeff BENNYHOFF discussed housing projects using ARPA funds, reallocating ARPA funds, and funding details of the Broadband Project.

Astrid MORALES, Merced - spoke on the importance of continuing to allocate funds to youth programs.

Miranda GRISWOLD, Merced - spoke in support of allocating remaining funds to the Utility Relief Program and additional funds to the Youth Job Program.

Rick WENDLING, Merced - spoke on street and road maintenance funding and bringing local businesses.

Gloria SANDOVAL, Merced - spoke in support of more youth jobs and suggested to create a hot-line where citizens can report incidents in Merced.

Mrs. DIETZ stated that citizens can call the Merced Police Department non-emergency line or report incidents on the Merced Connect Application.

Tom SIVERLY, Merced United Soccer Board, Merced - asked if there were additional funds for lighting at McNamara Park.

Fernando AGUILERA, Merced - spoke on the importance of soccer in the community and asked for more soccer fields and lighting.

Josue HERRERA, Merced - proposed an option for water conservation to Council and spoke in support of youth jobs.

Pangcha VANG, Merced - asked for updates on remaining programs funded by ARPA, spoke on making parks more accessible to the community, and in support of youth job programs.

Crisantema GALLARDO, Merced - voiced support to allocate ARPA funds to the Youth Job Program.

Ale, Merced - spoke in support of the Youth Job Program.

Council, Mrs. DIETZ, Finance Officer Venus RODRIGUEZ, Interim City Attorney Travis LINDSEY discussed details of the Utility Relief Program,

the amount of utility accounts in the Census track, the remaining balance to allocate, Council's general support for different programs, details of the Stimulus Program, community outreach efforts, details of the motion, and whether to reconsider the motion.

Council agreed to direct staff to allocate \$1 million to affordable housing, allocate \$3.35 million to Community Park 42, leave the Utility Relief Program open with remaining amount of \$810,111, receive an update on the census track in six months, allocate \$1.175 million to jobs program, and allocating \$425,000 to the Applegate Restrooms Project.
