Council Member LOR asked about the money that was borrowed for the Atwater Merced Expressway (AME) and if the Regional Transportation Impact Fees (RTIF) was to pay this back. He also stated his disapproval for this item.

Mayor THURSTON explained how the AME was funded and the role the RTIF had.

Council Member MURPHY emphasized that developers do pay other fees.

Mayor Pro Tempore PEDROZO discussed other regional projects the funds could be allocated to.

Mayor THURSTON asked about the lost projects due to RTIF.

Director of Development Services Dave GONZALVES explained that the fees were too high for developers to bring projects to Merced.

Economic Development Director Frank QUINTERO discussed his meeting with three teams of developers and the potential of suspending the impact fees.

# K.1. SUBJECT: <u>General Plan Amendment #16-03 - Adoption of Revised</u> Housing Element

#### **REPORT IN BRIEF**

This General Plan Amendment involves the review and adoption of the Revised Housing Element. If adopted, the Housing Element would be forwarded to the California Department of Housing and Community Development (HCD) for final review.

#### RECOMMENDATION

**City Council** - Adopt a motion adopting **Resolution No. 2016-34**, a Resolution of the City Council of the City of Merced, California Adopting a Negative Declaration and Amending the Housing Element of the General Plan, with any required changes per HCD.

Associate Planner Julie NELSON gave a slide show presentation on the Housing Element.

Mayor THURSTON asked about integrating neighborhoods, if the City is expanding financial opportunities to lower-income families, and clarification on building power and leadership in marginalized communities.

Ms. NELSON explained what their strategies are for their future integrated plans. She stated the City offers housing programs for lower-income families.

Council Member MURPHY asked about the population assumptions and what the consequence was in overstating populations and number of units.

Ms. NELSON explained the Merced County Association of Governments (MCAG) used the population projections. She stated she didn't know if there were any consequences.

Council and Ms. NELSON discussed the population numbers and the General Plan.

Council Member LOR stated that he wanted a low income housing element in all projects.

Council Member BELLUOMINI asked about the UC Merced Student Housing Plan and if developers are required to include affordable housing as part of their development.

Ms. NELSON explained that UC does not have a developed plan in place. She also explained that it was not feasible for developers to include affordable housing in all projects.

Mayor THURSTON opened the Public Hearing at 8:32 PM and subsequently closed the Public Hearing with no members of the audience

Mayor THURSTON called the Regular Meeting back to order at 8:55 PM.

SUBJECT: Zoning Ordinance Amendment #16-02 Regarding Medical Marijuana Dispensaries, Deliveries, and Cultivation for Qualified Patients

## **REPORT IN BRIEF**

Consider adoption of an ordinance to establish regulations for medical marijuana dispensaries, deliveries, and cultivation for qualified patients.

## RECOMMENDATION

City Council - Adopt a motion approving one of the following options:

A. Adopt a Negative Declaration and Introduce **Ordinance 2463** (as recommended by the Planning Commission) that would allow medical marijuana dispensaries in the Professional/Commercial Office (C-O), Light Industrial (I-L), and Heavy Industrial (I-H) zones with a conditional use permit; allow delivery of medical marijuana under specific circumstances; and allow limited growth, indoors only, of medical marijuana (6 plants or less per lot) for a qualified patient:

"An Ordinance of the City Council of the City of Merced, California, Amending Chapter 20.84, "Medical Marijuana and Cultivation" and amending Sections 20.20.040 "Conditional Uses," 20.34.040 "Conditional Uses," and 20.36.040 "Conditional Uses," of the Merced Municipal Code regarding the zoning of medical marijuana dispensaries as conditional uses".

B. Adopt a Negative Declaration and Introduce **Ordinance 2464** (as directed by the City Council on April 20, 2016, and originally presented to the Planning Commission on May 18, 2016) that would allow medical marijuana dispensaries in the Professional/Commercial Office (C-O) zone with a conditional use permit; allow delivery of medical marijuana under specific circumstances; and allow limited growth of medical marijuana (12 immature or 6 mature plants or less per lot) for a qualified patient under specific circumstances:

C. Approving a supplemental appropriation in Fund 017 in the amount of \$2,260 to pay for State filing fees for the Negative Declaration and allowing the Finance officer to make the necessary budget adjustments.

Senior Deputy City Attorney Ken ROZELL gave a slide show presentation to review the Medical Marijuana Ordinance.

David MCPHERSON, professional consultant - discussed his knowledge and background on Medical Marijuana Management and his experience working with cities in California.

Council asked about the process of reviewing applications and appeals of applications, regulations on dispensaries, products, and deliveries.

Mr. MCPHERSON explained the criteria to accept an application. He briefly went over the process of appealing applications. He stated the State regulates the quality of the product, then further explained the process of the quality control. He said that if deliveries are allowed, any licensed dispensary from out of the area could deliver in the city.

Council Member BLAKE asked if Mr. MCPHERSON has done comprehensive regulations on a City similar to Merced and how long it took.

Mr. MCPHERSON gave an example of the City of Salinas and that it took 120 days to construct city regulations.

Council asked about the cost for the City to review applications and regulations and the cost to hire a consultant to set up the procedures and regulation policies.

Mr. MCPHERSON stated that applicants would pay fees, and that this would allow the City to recoup the cost. He discussed the cost of hiring a consultant to develop regulations and policies.

Council Member MURPHY asked if having a consultant would help City staff facilitate the process.

Director of Development Services GONZALVES stated that having a resource to help the process would be of great assistance.

Council Member BELLUOMINI stated that he would like to move forward and have staff draft an ordinance to go in effect in 180 days and have the consultant give the Council a proposal on how to go about the process.

Council discussed opening a bid process to hire a consultant.

Mayor THURSTON opened the continued Public Hearing at 9:47 PM.

Eric MOORE, Merced - stated his support for Medical Marijuana.

Dennis NEBEKAR - stated his support for Medical Marijuana.

Mayor THURSTON closed the Public Hearing at 9:55 PM.

Council Member DOSSETTI motioned to approve the Planning Commission's recommendation allowing the growth of six plants indoors, four dispensaries, with the exclusion of industrial zones. Once the State licensing and the City of Merced regulatory process is in place, then to open the application process for dispensaries.

Council Members discussed the clarification of Council Member DOSSETTI's motion.

Council Member BELLUOMINI seconded the motion.

Council Member MURPHY objected the motion and stated the process was unusual and irregluar.

Council Members continued discussion of the ordinance, the criteria, and

regulations of dispensaries.

Mayor Pro Tempore PEDROZO stated his support for the motion.

Council Member LOR stated his concerns for childrens' safety and crime. He stated he would compromise with allowing growth indoors and outdoors, and start with four dispensaries but add more based on applications.

Interim City Attorney Kelly FINCHER stated that the implementation of an ordinance cannot be delayed, but suggested as an alternative that the ordinance state that applications for dispensaries not be accepted until after regulations are approved by the city.

Council Member DOSSETTI withdrew his motion after further discussion with Council.

**Clerk's Note:** The ordinance is to be amended based upon Council Member BELLUOMINI's motion and returned to the next meeting for a first reading.

A motion was made by Council Member Belluomini, seconded by Council Member Blake, approving staff recommendation but exculding the industrial zones, allowing the growth of six plants indoors, allowing for four dispensaries to operate in the City with deliveries after the regulations governing the dispensaries are approved by the City Council. The motion carried by the following vote:

## L. REPORTS

# L.1. SUBJECT: <u>Code Enforcement/Animal Control Update</u>

## **REPORT IN BRIEF**

Provides an update to the Code Enforcement/Animal Control Division of the Police Department as requested by Council Member Murphy.

## RECOMMENDATION

For Information Only.

Police Chief ANDRADE, Lieutenant Don KING, and Sergeant Alan WARD gave a slide show presentation on Code Enforcement and Animal Control.

Sergeant WARD discussed the challenges having to relearn and recreate procedures. They are working to create better communication. They are looking at the licensing process and educating residents about pet licensing.

Council Member MURPHY stated he was encouraged that DART and Code Enforcement are working together and the higher case load is a positive sign that more violations were being rectified. He asked if process servers were used to find owners and if transferring weed abatement issues to the Fire Department would help alleviate the workload.

Sergeant WARD explained that they do not use process servers and finds that most owners refuse to correct violations. He explained that from April 25th to June 1st, the Fire Department takes over weed abatement; but outside of that, it is Code Enforcement's responsibility. He discussed the weed abatement process Code Enforcement goes through.

Fire Chief HENRY discussed the Fire Department's role in weed abatement and the processes they go through.

Police Chief ANDRADE addressed the issues of weed abatement and suggested the Council look into who should be responsible for it.

Council Member MURPHY suggested that Staff come back with recommendations on how to improve Code Enforcement.

Council Member BELLUOMINI asked about the process of handling unpaid citations.

Sergeant WARD explained the process of fining and eventually placing liens on the properties.
