Water Conservation Specialist Leah BROWN explained the timeframe of the study used to determine the amount of water used and calculated the average.

Robert LINDEN, Merced - spoke on his water usage and the proposed water rate change.

Ruby RAY, Merced - spoke on her concern with her water bill.

Alan CLAUNCH, Merced - spoke on the cost of water usage for residents.

Rob CARRIER, Merced - spoke on his concern for residents that have a full house and the effect on their water bill.

Benjamin KURTZ, Merced - spoke on the proposed water rate change.

Cecilia NICHOLS, Merced - spoke on the calculations of the water rate and the effects on the lower income families.

Rick WENDLING, Merced - spoke on the capital cost, labor cost, and the State Water Board.

Mayor Pro Tempore MCLEOD and Mr. HILDABRAND discussed a tiered system.

Christine CLARKSON, Merced - spoke on her water bill increase and her opposition to the water rate change.
