Principal Planner Michael HREN gave a slide show presentation on amending the zoning ordinance.

Council and Mr. HREN discussed the expiration of the applicants list, the permits and fees, the definition of school, 180 day applicant list, and an annual school site map.

Mayor MURPHY opened the Public Hearing at 8:09 PM.

Raj POTTABATHNI, San Francisco - spoke on his Cannabis company and stated his opposition to revise the Ordinance.

Mayor MURPHY closed the Public Hearing at 8:15 PM.

Council continued to discuss the definition of school, the school site map, and the applicant list process.

Attorney Kim FLORES suggested writing language regarding the definition of a school in the Ordinance.

Director of Development Services Scott MCBRIDE spoke on the two different processes that they have for the limited number of Cannabis dispensary businesses and unlimited number for other businesses.

Council, Mr. MCBRIDE, and Ms. FLORES discussed a standing list by Resolution, how often to update it, and the language used to define a school.

Provides direction to staff regarding the funding of the Section 115 Post Employment Benefit Trust, Also requests a determination of asset allocation, and Adoption of investment guidelines for the Section 115 Post Employment Benefit Trust.

Finance Officer Venus RODRIGUEZ, Highmark Capital Investment Advisor Andrew BROWN, and PARS Senior Manager Rachel SANDERS gave a

slide show presentation on the Trust 115 - Pension.

Council and Mr. Brown discussed conservative vs. moderately conservative investing, actively managed funds, benchmarks, and fixed incomes.

Michael BELLUOMINI, Merced - asked about Highmarks rate of return compared to CalPers.

Mr. BROWN explained the success of Highmarks investments and the benefits of their company.

Council and Ms. RODRIGUEZ discussed the City's investment policy, the Enterprise Fund, Charter Amendments, length of investment, and CalPers cost increase. They also discussed the Revenue Stabilization Fund and amount to invest.

A motion was made by Council Member McLeod, seconded by Council Member Blake, to transfer \$2 million from the Wastewater System Fund and \$1.3 Million from the Water System Fund to the Trust 115 Fund. The motion carried by the following vote:
