Consider accepting nominations and appointing two applicants to the Planning Commission.

##### **RECOMMENDATION**

**City Council** - Adopt a motion accepting nominations and appointing two individuals to the Planning Commission with one term ending date of July

1, 2019 and one term ending date of July 1, 2021.

Council Members discussed the qualifications of the applicants and stated preferences to fill the two vacancies.

Council Member PEDROZO stated concern that two applicants did not show up to the interview and about the absence of two Council Members.

A motion was made by Council Member SERRATTO to nominate Daniel CARIS to the Planning Commission. The motion failed for a lack of second.

**A motion was made by Council Member Pedrozo, seconded by Council Member Belluomini, to appoint Sonia Alshami to the Planning Commission. The motion carried by the following vote:**

**No:** 2 - Council Member Martinez, and Council Member Serratto

**Absent:** 2 - Mayor Pro Tempore McLeod, and Council Member Blake
