Richard HARRIMAN, on behalf of the appellants Merced Smart Growth Associates and Casey STEED, asked Council to approve the appeal and deny the project based on several factors including the site plan review process, potential noise, non compliance with the zoning ordinance and issues with various CEQA items.

Elisa PASTER, on behalf of the applicant Merced Holdings LP., discussed the compromises the applicant has made based on Council direction given at a previous meeting, stated it meets all design standards, and requested that Council deny the appeal and approve the project.

Michael BELLUOMINI, Merced resident - suggested approval only if the project was reduced in size, adjusted to meet residential design standards in the Zoning Ordinance, and suggested the ground floor be retail and offices.

Dan ALEMAN and Janet HUGHES, Merced residents - requested denial of the project based on the size of the project, the traffic issues it will cause, and the sewer issues created.
