REPORT IN BRIEF

The City Council will conduct a public hearing and consider the introduction of an Ordinance which would modify the Development Agreement for Bellevue Ranch to extend the term of the Agreement for the remaining portions of Bellevue Ranch West (generally north of Cardella, west of G Street) from 25 years to 40 years.

RECOMMENDATION

City Council - Adopt a motion:

A. Adopting a Categorical Exemption (Environmental Review #20-12) per the California Environmental Quality Act (CEQA); and,

B. Introducing **Ordinance No. 2516**, An Ordinance of the City Council of the City of Merced, California, amending Ordinance No. 1906 to modify the term of the development agreement for Bellevue Ranch for the remaining portion of Bellevue Ranch West from 25 Years to 40 Years.

Planning Manager Kim ESPINOSA gave a slide show presentation on amending a Development Agreement from 25 years to 40 years initiated by Baxter Ranches LLC and Stonefield Homes, Inc.

Gabriela SPIVA, Merced - spoke about the censure of Council Member ECHEVARRIA and the need for more stringent action.

De ZHEN ZHOU, Merced - asked that Council Member ECHEVARRIA correct his actions or resign.

Melinda GONZALES, Merced - called for the resignation of Council Member ECHEVARRIA.

Kedra AVERY, Merced - called for the resignation of Council Member ECHEVARRIA.

Jesse ORNELAS, Merced - expressed his concerns over Council Member ECHEVARRIA's recent conduct.

Council and Ms. NORTON discussed the limitations placed on the Council in regards to Council Member ECHEVARRIA's conduct.

Sam RANGEL, Merced - questioned the efficiency of Council with a member that is not aligned with the rest of Council.

Council provided direction to staff regarding language to be placed in a resolution of censure.

City Manager CARRIGAN and Council discussed the timeline to bring the resolution back to Council.
