Comments questions and topics included, affordable housing, inclusionary zoning, a first time homebuyer program, rental registration programs, traffic and pedestrian safety, homeless encampments, Laura Fountain restoration efforts, bike path improvements, community events, youth programs, and marijuana businesses.
