REPORT IN BRIEF

Consider accepting nominations and appointing two applicants to the Planning Commission.

RECOMMENDATION

City Council - Adopt a motion accepting nominations and appointing two individuals to the Planning Commission with one term ending date of July 1, 2022 and one term ending date of July 1, 2021.

ALTERNATIVES

AUTHORITY

DISCUSSION

The term of Commissioner Travis Colby ended on July 1, 2018 and he is currently serving until a replacement appointment is made. Additionally, a second seat has become available due to a recent resignation on the Commission.

The City Clerk's Office advertised for the vacancies and received four new applications (attached).

The current roster for the Commission is attached. The matter of appointment to this Commission is now before the Council.

History and Past Actions:

The Planning Commission, created by City Charter, studies land subdivision, planning, and zoning matters. The Commission recommends to the City Council the adoption, amendment, or repeal of the City's Master Plan for the physical development of the City. The Commission consists of seven members who are qualified electors of the City of Merced. Meetings are held on the first and third Wednesdays of each month at 7:00 p.m.
