# DISCUSSION

On January 23<sup>rd</sup> and 29<sup>th</sup> and February 15<sup>th</sup>, the City Council held Town Hall meetings to solicit input from the community regarding the upcoming FY 2024/25 Budget and City workplan. Following the Town Halls, the City Council convened a Strategic Planning Session on February 24<sup>th</sup> to review and discuss various topics.
