DISCUSSION

Background:

On December 16, 2013, the City Council approved Resolution No. 2013-52, which continued the Merced Fire Department's fire prevention fees until a Fee Study Analysis could be conducted and a subsequent resolution adopted modifying those fees.

A consultant, NBS, completed the Merced Fire Department (MFD) *draft* Fee Study Analysis and the findings were presented to the City Council at their March 21, 2016 study session and to the Greater Merced Chamber of Commerce. The *final* Fee Study Analysis has been completed and the MFD is requesting a public hearing to allow public input and comment on the proposed fees and charges prior to updating its fee schedule.
