DISCUSSION

The City of Merced currently offers Roth and Traditional IRA Plans through ICMA-Retirement Corporation. ICMA-Retirement Corporation recently announced the fund restructuring of its proprietary investment options to a collective investment trust only structure. To accomplish this the IRAs currently available to participants are scheduled to close September 2016.

ICMA-Retirement Corporation is offering a Vantagepoint Payroll Deduction IRA Program as an alternative to the Plan that is closing. Existing participants enrolled in the current plan will be able to roll over assets into this new platform. An ICMA-Retirement Corporation specialist will notify and work directly with participants to assist with transferring assets.
