DISCUSSION

On August 7, 2017, the City Council appointed M. Venus Rodriguez as the Interim Finance Officer. This appointment requires the City of Merced to update authorizations to sign City checks and other documents evidencing payment of funds on behalf of the City of Merced and to use a facsimile signature. Modification to who is authorized to withdraw City funds from the Local Agency Investment Fund in the State Treasury is also required.
