SUBJECT: First Amendment to Landscape Maintenance Services Agreement - "G" Street Undercrossing Landscape Development

REPORT IN BRIEF

Consider approving a one-year extension with Yard Masters, Incorporated, for the period of August 1, 2017 through June 30, 2018, for landscape maintenance services at the "G" Street railroad undercrossing landscape development.

RECOMMENDATION

CITY COUNCIL PRIORITIES

DISCUSSION

The Public Works Department is requesting approval of a one-year landscape maintenance services agreement with Yard Masters, effective August 1, 2017 through June 30, 2018.

Yard Masters continues to provide quality, cost-effective landscape maintenance services to this recently-developed landscaped area, located on the east and west sides of "G" Street, between East 23rd and 26th Streets, including the center median.

It is crucial that maintenance services continue in this heavily-traveled thoroughfare, due to its high visibility and to the initial funding expended to design and install the existing landscape.

Therefore, Staff recommends Council approve this amendment to Yard Masters through June 30, 2018. All terms and conditions of the agreement remain in effect.

IMPACT ON CITY RESOURCES

The City's Finance Department has verified funding for this work and it is included in the Fiscal Year 2017/2018 Adopted Budget under account line 022-1104-532.17-00.

The City Attorney's office has prepared the necessary First Amendment to the landscape services agreement for your review and approval.
