## **DISCUSSION**

City staff has been in contact with Union Pacific Railroad (UPRR) to set up a diagnostic meeting. The diagnostic meeting will include the following stakeholders: UPRR, California Public Utilities Commission, and the City's consultant, JLB Traffic Engineers. UPRR will not attend the meeting without having a signed agreement.

The City received two CMAQ Grants, one for a traffic signal CML-5085(040) and the other for a southbound right-turn lane CML-5085(044). In order to meet funding requirements, staff needs to have this project awarded this year.

## IMPACT ON CITY RESOURCES

This project was established as a Capital Improvement Project and account 450-1104-637.65-00-114052 contains sufficient funding to cover this agreement.
