REPORT IN BRIEF

DISCUSSION

The California Shared Habitat Alliance for Recreational Enhancement (SHARE) Program assists with facilitating public access to private lands, by providing private landowners or their representatives, annual incentive payments in return for providing public use of their land for wildlife dependent recreational activities. The activities that will be offered at the Wastewater Treatment Plant (WWTP) through the SHARE program are bird watching and dove, waterfowl and pheasant hunting.

The City of Merced first entered in to the 3-year SHARE agreement in 2013. Prior to 2013, all hunting permits for the WWTP were sold by the City's Parks and Recreation Department, which generated approximately \$2,840. The SHARE program allows the City to continue selling permits on certain days, but also pays the City \$7,050 per year for the permits issued through CA Fish and Wildlife. It has been a good program for the City as well as the community residents. This contract is for a 7-month term due to staffing changes at the Fish and Wildlife Department, and it should return to a 3-year term after the completion of this contract.

IMPACT ON CITY RESOURCES

This revenue is included in the FY2019-20 Proposed Budget.
