## AUTHORITY

Charter of the City of Merced, Section 200, et seq.

Municipal Code Chapter 3.04, Article IV - Public Works Contracts. Every project involving an expenditure of more than the adjusted amount of seventy thousand, nine hundred and thirty-nine dollars (\$70,939) for the construction or improvements of public buildings, works, streets, drains, sewers, utilities, parks, and playgrounds shall be let by contract to the lowest responsive and responsible bidder after notice by publication in the official newspaper by one or more insertions, the first of which shall be at least ten days before the time for opening bids.

## DISCUSSION

Engineering staff, prepared plans and specifications for the work. The engineer's estimate was \$45,000 for the project that was advertised and the bids opened on July 25, 2019, with the following results:
