CITY COUNCIL PRIORITIES

As provided for in the 2019-2020 Adopted Budget.

DISCUSSION

The City's negotiations team and the Merced Association of City Employees (MACE) have completed the collective bargaining process and have reached agreement on an 12-month extension of the existing contract. Due to the economic uncertainty that has come as a result of the COVID-19 pandemic, both parties acknowledge that an extension of the current MOU will be in the best interest of both the City, and the Association. The agreement will provide stability during the unprecedented times the City is facing. The extension is consistent with City Council direction.

Unless a provision of the current MOU was set to sunset, all other provisions of the 2018-2019 Memorandum of Understanding will be extended through December 31,2020. Staff recommends adoption of the Resolution approving the Memorandum of Understanding.

IMPACT ON CITY RESOURCES

No additional budget appropriation is necessary.
