**SUBJECT:** Adoption of a Resolution Re-Certifying the Updated City of Merced's Sewer System Management Plan for the Period of June 2020 Through June 2025

### REPORT IN BRIEF

Requests the City Council to re-certify the updated Sewer System Management Plan.

## **CITY COUNCIL PRIORITIES**

## **DISCUSSION**

The State Water Resources Control Board (State Water Board) adopted the Monitoring and Reporting Program (MRP) No. 2006-0003 Statewide General Waste Discharge Requirements (WDR's) for Sanitary Sewer Systems on May 2, 2006. The WDR mandates the City of Merced to:

- Develop and implement a system specific Sewer System Management Plan (SSMP),
- Upgrade monitoring, record keeping, sampling, and testing procedures to report electronically,
- Institute an annual internal audit program and provide regular public outreach and notification

The WDR also mandates the City of Merced to update the SSMP every five (5) years, and to have the SSMP re-certified by the City's governing board when significant changes have been made.

As required, Staff has conducted regular internal audits of the SSMP. These regular audits have resulted in the SSMP being changed and updated, and now requires City Council approval (see attachment 1).

Updates and changes to the SSMP were tracked on a spreadsheet showing the original text and the replacement text (see attachment 2).

Council adopted Resolution 2015-17 approving the original SSMP at their June 1, 2015 meeting. Staff now requests City Council to approve Resolution 2020-xx to recertify the updated SSMP in order to maintain compliance with the State Water Board WDR's (see attachment 3).
