Annual Conference resolutions guide cities and the League in efforts to improve the quality, responsiveness, and vitality of local government in California. Therefore, it is very important that all cities be represented at the Business Meeting on Friday, October 9, 2020, virtually.

DISCUSSION

To expedite the conduct of business at this important policy-making meeting, each City Council is asked to designate a voting representative and two alternates who will be present at the virtual Annual Business meeting. The League by-laws provide that each city is entitled to one vote in matters affecting municipal or League policy.

If the Mayor or a member of the City Council is in attendance at the Annual Business Meeting, it is expected that one of these officials will be designated as the voting delegate. However, if the City Council does not have a registered delegate at the conference, but will be represented by other City officials, one of the other officials can be designated the voting delegate or alternate. Due to the COVID-19 pandemic, the Annual Conference was schedule to take place in Long Beach, CA, has been moved to a virtual event.
