#### DISCUSSION

The NAACP, the Hispanic Chamber of Commerce, and WeCed Organizations presented their Black Lives Matter street mural project to the Arts and Culture Advisory Commission. They requested the Commission to give their recommendation to the City Council the location of the project as well as their support for the proposed mural. The Arts and Culture Advisory Commission unanimously voted to strongly recommend the support of the City Council for the proposed mural and unanimously voted to place the proposed mural on Canal Street and 16<sup>th</sup> Street.

#### IMPACT ON CITY RESOURCES

The proposed project has received funding from the community, no anticipated impact on city resources. Should the Council request staff to assist, in-kind staff time would be available to support the project.
