CITY COUNCIL PRIORITIES

As provided for in the 2020-21 Adopted Budget.

DISCUSSION

The Merced Police Department has been providing Merced Community College District with a Police Captain to oversee police operations at the District since 2016. The agreement has been drafted, which provides for the City to be reimbursed by the College for the salary and benefit costs of a Police Captain who will serve as the College Police Department's Chief Administrator for the 2020/21 fiscal year in the amount of \$234,554.44 to be paid in monthly payments. The Police Captain will be an employee of the City. The term of the agreement is from September 1, 2020 to September 1, 2021.

The City and the College will be working together on several notable collaborative efforts. Specifically, as detailed in Section 10 of the agreement, as part of this Agreement, Merced College will allow the City's Police and Fire Departments to periodically conduct trainings and meetings in their available classrooms, facilities and other areas of their campuses at no cost to the City.

IMPACT ON CITY RESOURCES

Funding will be provided for the position by the Merced Community College District as outlined in the contract and was accounted for in the adopted FY 2020/21 Budget.
