#### DISCUSSION

During the 2018-2019 fiscal year, Koff & Associates was awarded an agreement for Professional Services to conduct a Citywide employee total compensation study. With approximately 160 classifications to review, it was determined that hiring an outside firm would be the best way to accomplish the task.

The City had initially allocated \$75,040 for the study. The City is in the final stages of the study. Additional information requests have been made of the Consultant that fall outside of the scope of the services to be performed pursuant to the original agreement. The City is requesting an additional amount to cover the additional scope of services and the costs associated with the additional services being performed by Koff & Associates.
