Annexation of property into the City's existing CFD No. 2003-2 (Services) pursuant to Merced City Charter, Section 200; Chapter 2.5 (commencing with Section 53311_ of Part 1 of Division 2 of Title 5 of California Government Code (the "Act"), commonly known as the "Mello-Roos Community Facilities Act of 1982;" and the City's Policy on new development.

DISCUSSION

Pursuant to the Act and the City's policies, on January 3, 2023, the City Council, acting as the Legislative Body of the CFD, declared its intention to annex certain property to the Community Facilities District (CFD) No. 2003-2 (Services) for the property located on the East Side of G Street, approximately 1,100 feet North of Cardella Road (Attachment 1) (the "Development"). Also, on January 3, 2023, the City Council accepted a Petition, Consent, and Waiver from C.E.B. Holdings, LLC.

In accordance with the Act, a map of the proposed boundaries of Annexation No. 22 was recorded with the County Recorder's Office on January 5, 2023, (Attachment 2). The CFD Report for Annexation No. 22 is provided at Attachment 3.

A public hearing was properly noticed for this evening and will involve a number of specific steps that must be completed in order. City staff will outline those steps in order for the City Council at the start of the public hearing. In general, those steps will include the following: 1) Provided there is no majority protest at the close of the public hearing, the City Council may call a special election for this evening for the annexation to the CFD of Annexation No. 22; 2) The special election will ask the Developer to authorize: (a) the annexation to the CFD of Annexation No. 22; and, (b) the levy of an annual special tax within Annexation No. 22; 3) The City on behalf of the developers has submitted a sealed ballot to the City Clerk (the election official). Should the proposition pass with a two-thirds vote from the qualified voters (the landowner) as shown in the resolution canvassing the vote, the City may adopt the resolution of annexation.

The participating developer is responsible for the costs of the CFD annexation. A Deposit and Reimbursement Agreement was previously approved by the City Council and the appropriate deposit has been paid to the City.

Background

The project site was annexed into the City of Merced as part of the Absolute/Leeco Annexation in 2006. The tentative subdivision map for the project site was also approved in 2006. Through automatic extensions granted by the state and other extensions granted by the City, the tentative map has remains active through July16, 2023. The final map for the project site will be coming before the City Council in the near future for approval.

IMPACT ON CITY RESOURCES

The annexation of the property in CFD No. 2003-2 (Services) would allow a special tax to be levied on this property to cover the maintenance costs for landscaping in the public right-of-way, storm drain and pump maintenance, and street light maintenance, as well as a portion of the costs for Police and Fire services to the area. The property owner would be responsible for all maintenance costs until at least 50% of the development has been completed and sufficient funds have been collected by the CFD. At that point, the City would take over the maintenance to be funded by the CFD.
