## **DISCUSSION**

In December 2022, the City entered into an Agreement for Professional Services with the executive recruitment firm GVP Ventures, Inc. (formerly Bob Murray and Associates) in the amount of \$94,000, in order to assist with and coordinate the recruitment process.

The City would like to secure the services of the same recruitment firm to recruit for the position of City Manager. Additional funding in the amount of \$43,000 is necessary for the additional costs associated with recruiting for this position.

## **IMPACT ON CITY RESOURCES**

A supplemental appropriation is needed from the General Fund unreserved, unencumbered fund balance in the amount up to \$43,000, transferring to Fund 7008-Support Services and appropriating the same in the Personnel Professional service account line to cover the City Manager recruitment cost.
