#### DISCUSSION

The City has a need for legal expertise regarding telecommunication and internet infrastructure law, which the City Attorney's Office currently does not possess. Thus, the City wishes to enter into a contract with Telecom Law Firm PC, which specializes in telecommunication and internet infrastructure law.

The total cost of the service agreement with Telecom Law Firm PC shall not exceed \$50,000.

#### IMPACT ON CITY RESOURCES

Staff recommend appropriating from the unreserved, unencumbered General Fund balance in the amount of \$50,000, transferring to Fund 7008- Support Services and appropriating the same to IT Admin Professional Services.
